

Greetings Everyone,

The Squadron is still in need of vessel safety examiners. Now would be a great time to get on line and complete the program.

A couple of the new laws for 2012:

Beginning October 1, 2011, a person under the age of 16 shall not operate a personal watercraft on the waters of this state unless the person is not less than 14 years of age and one of the following circumstances applies:

- The person is riding the personal watercraft with his or her parent or guardian or an individual 21 years
 of age or older designated by the parent or guardian.
- The person is operating or riding a personal watercraft at a distance of not more than 100 feet from his or her parent or guardian or an individual 21 years of age or older designated by the parent or guardian.
